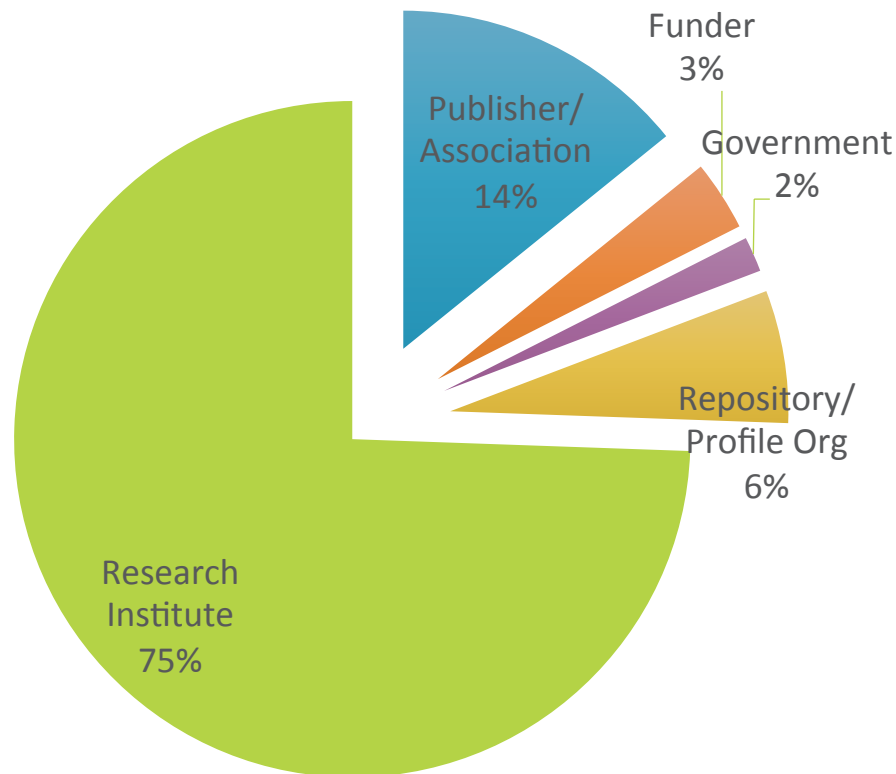
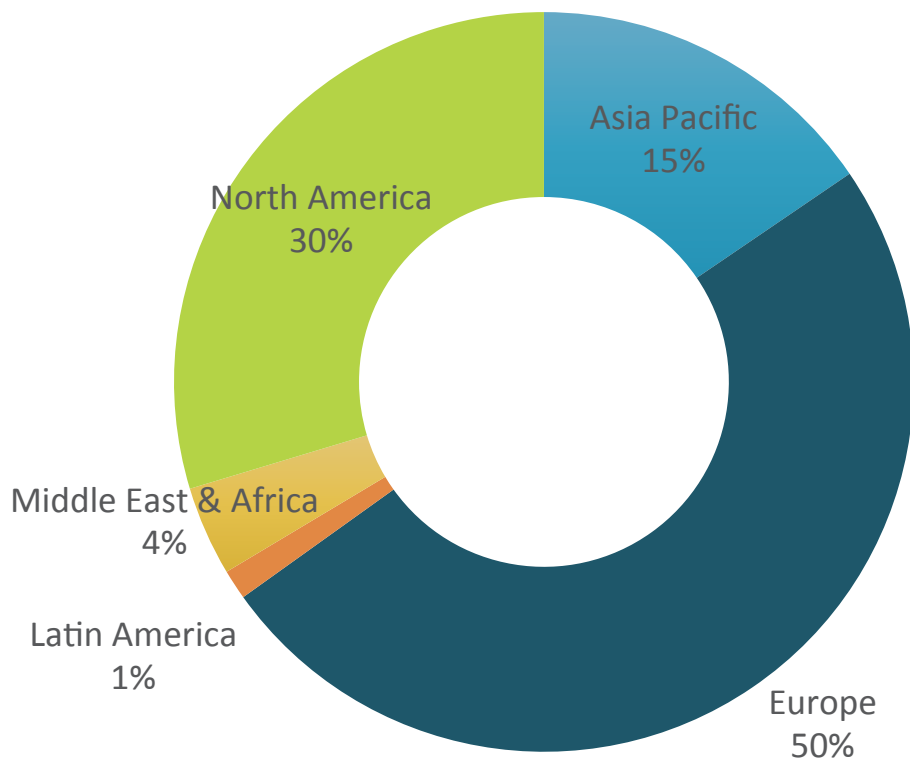
# THE ORCID COMMUNITY

- 60% growth in membership
- 550 members from 39 countries, including national consortia in the UK, Denmark, Finland, Netherlands, Belgium, Germany, Italy, Taiwan, Australia, New Zealand and 4 regional consortia in the US
- Over 250 integrations in each sector of the research community

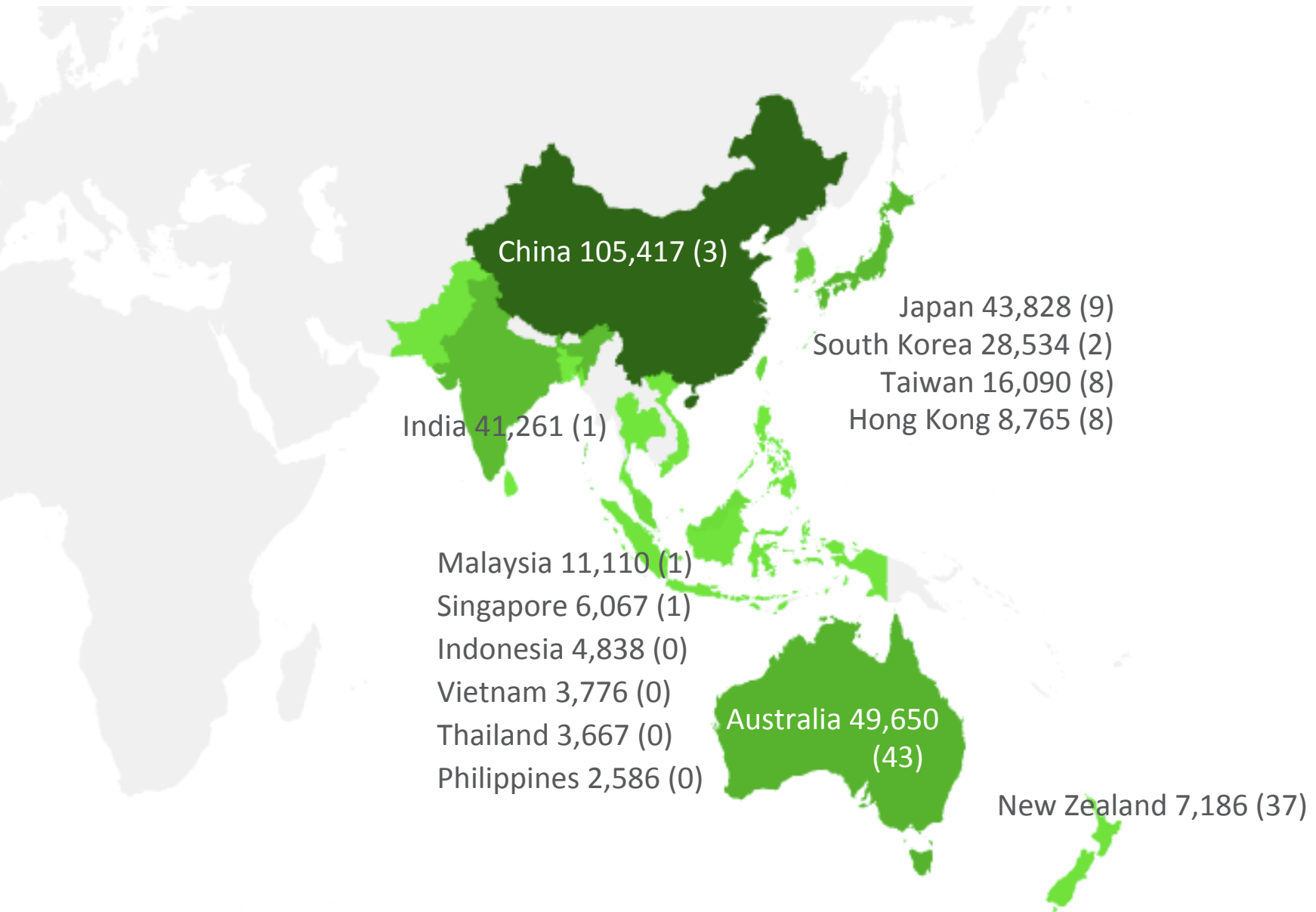


# COMMUNITY DISTRIBUTION

- Growth in Asia

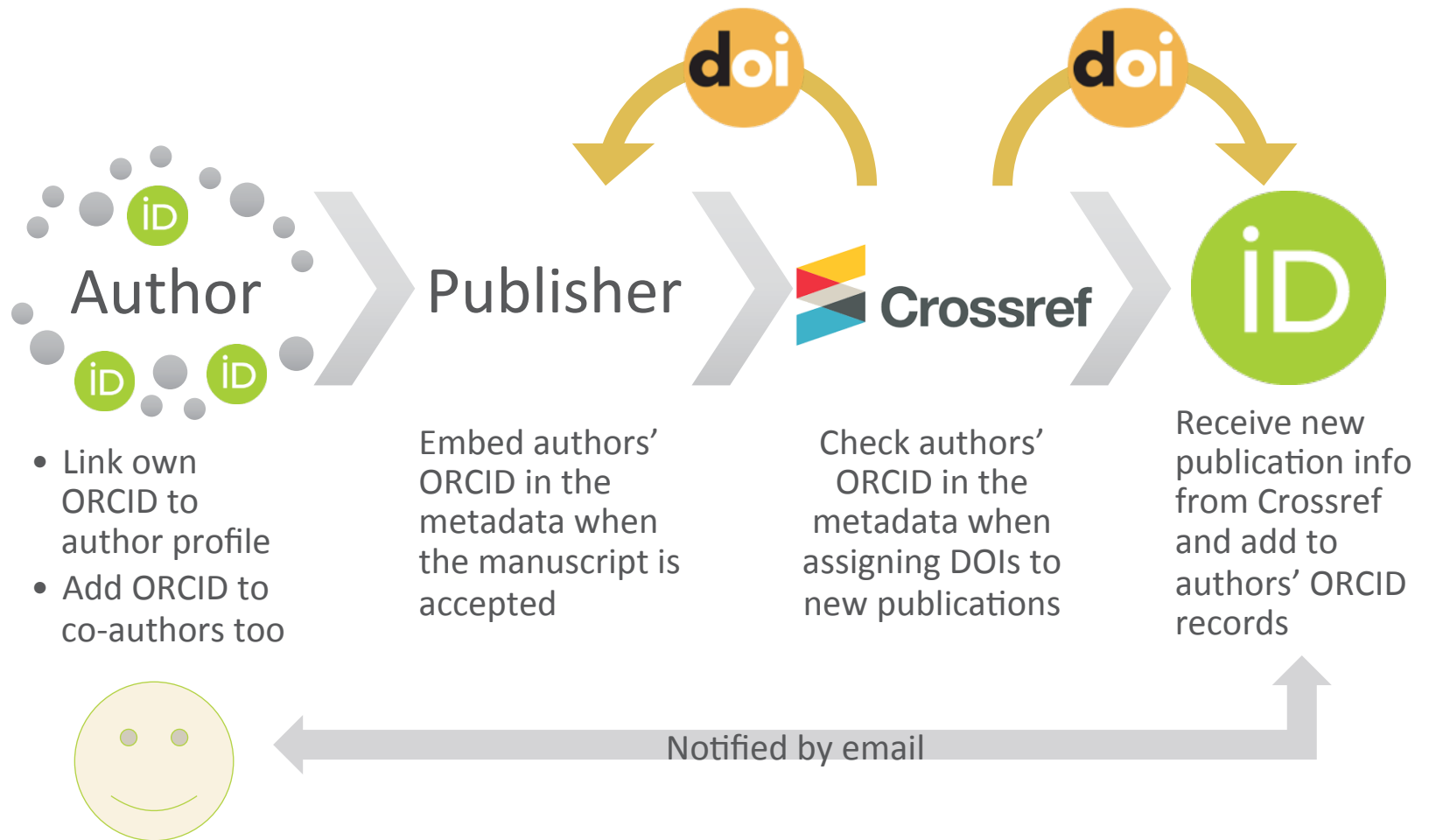

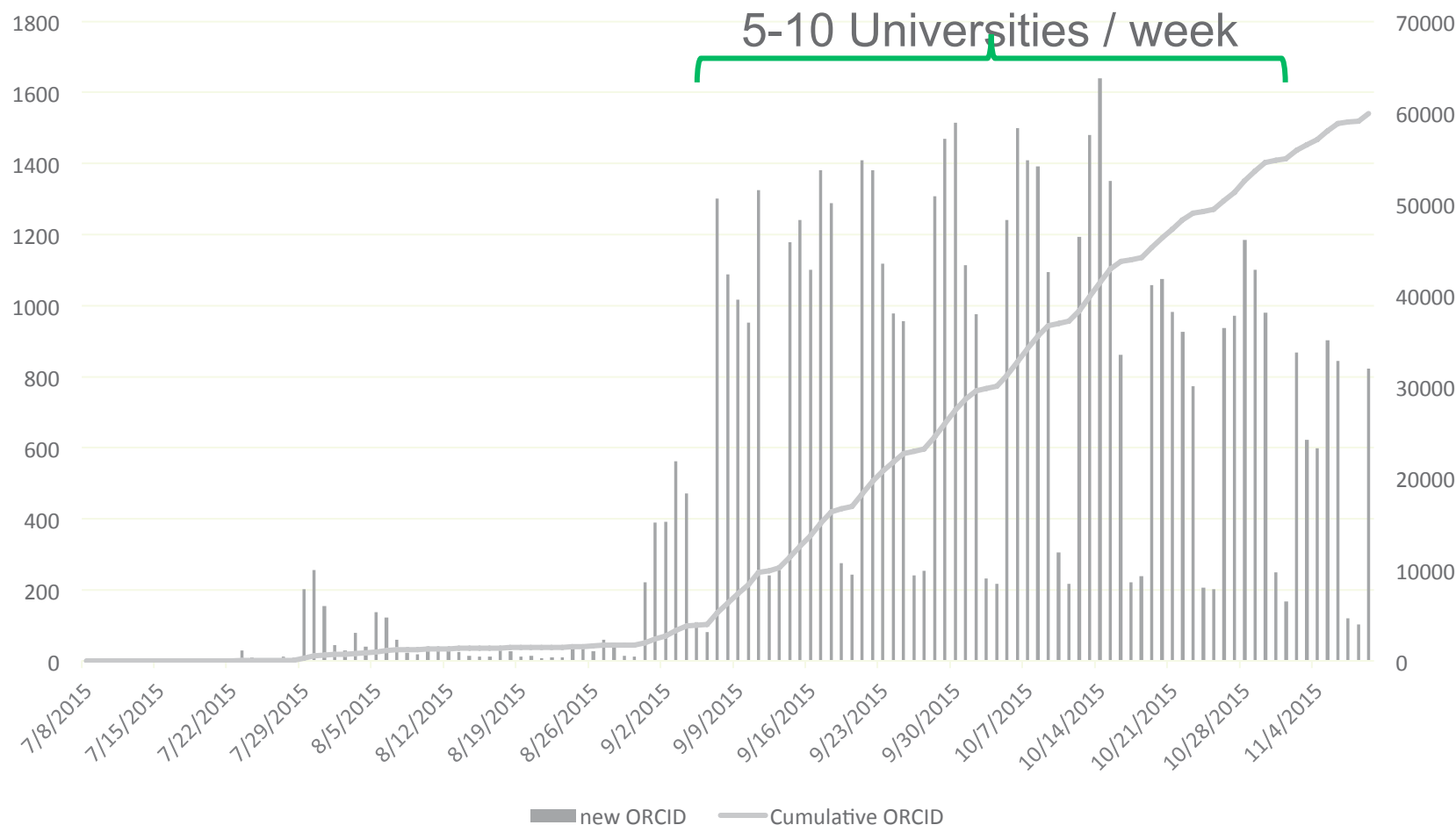

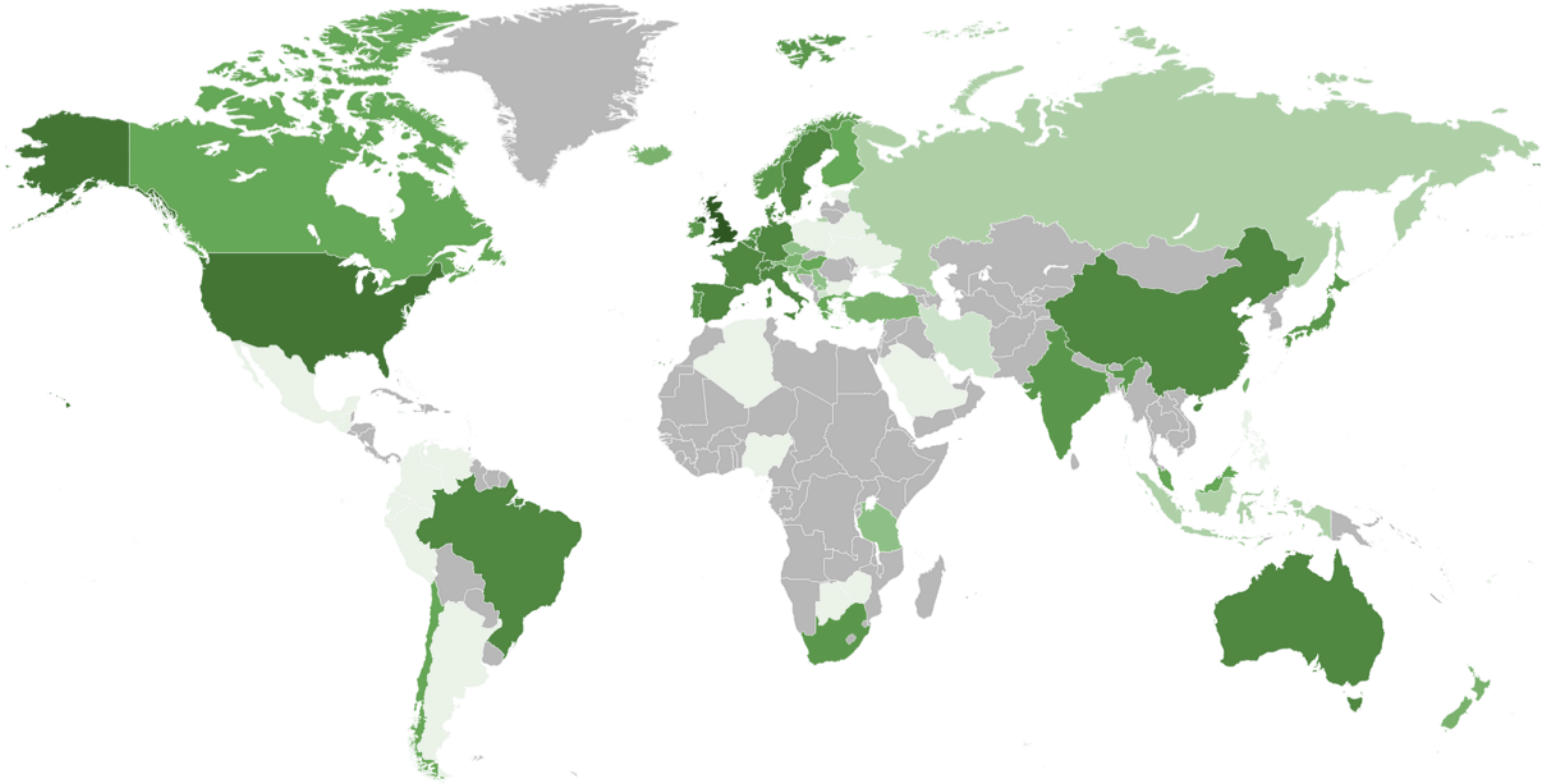
- Funded pilots for workflows (e.g. managing APCs) in two countries

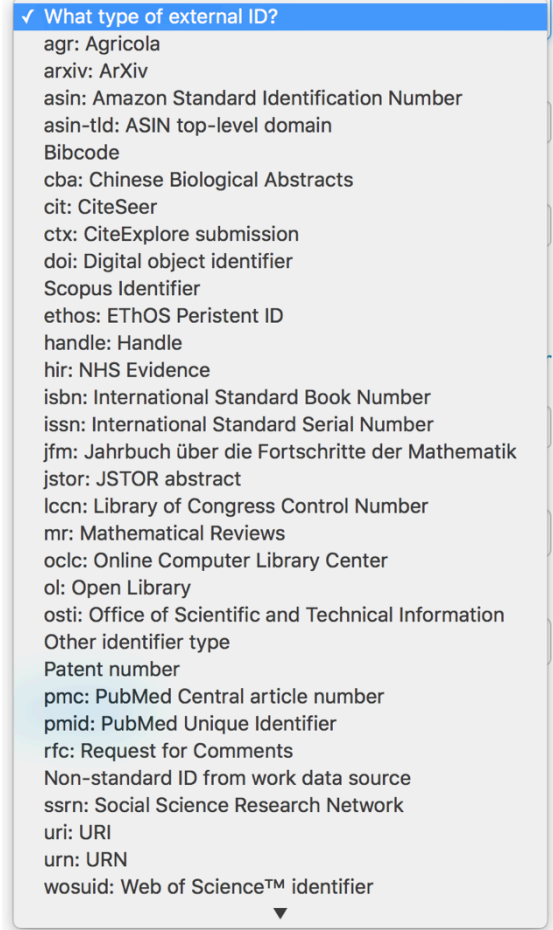
# MEMBER-REQUESTED EXTERNAL ID TYPES

There are *loads* of different identifiers out there

Different communities require different identifiers

It's hard for us to know which our members require

The solution? Let members request new types!





### Individual control

Our tools and services provide you control over your registration, what is connected to your iD, and who can access your information. We provide system security and protection to ensure that user control is maintained.



### Reliable registry

We understand that dependability, availability, security, and durability are required of the systems and services we provide for you and the organizations you work with in the research community.



### Community accountability

We make ourselves accountable to all who use and support ORCID activities through our non-profit status, our membership-based sustainability model, community governance, and data dispute procedures.



### Information integrity

We work with the community to enable high-fidelity connections between individuals and their contributions and affiliations. We have developed processes and tools for creating, managing, and interpreting ORCID Registry information.

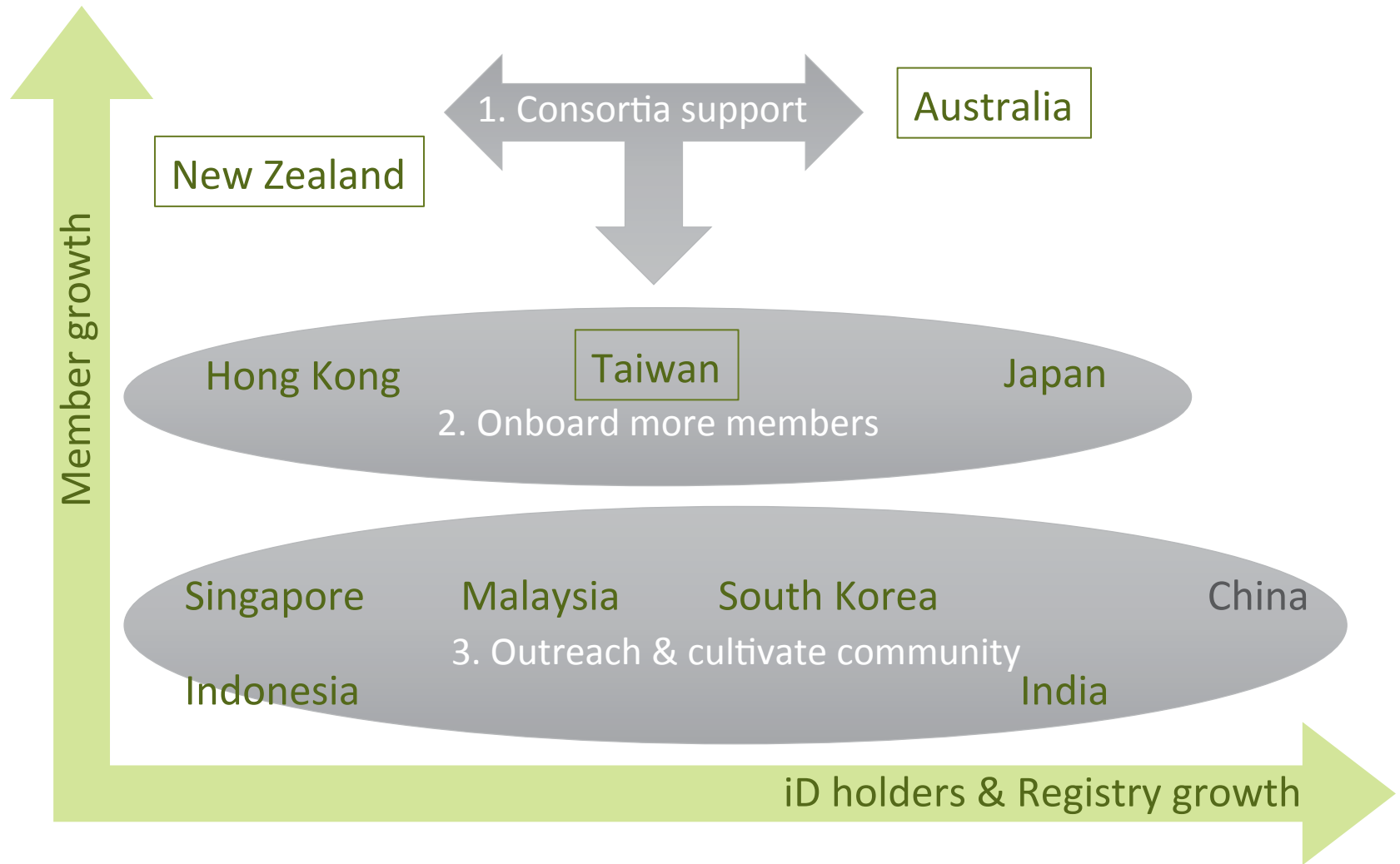
# ORCID ELECTIONS

The ORCID Board is responsible for ensuring the organization is acting in the best interests of ORCID stakeholders.

- provides strategic guidance for the successful achievement of ORCID's mission
- oversees the management of ORCID and its organizational performance, reviews high-level organizational goals and policies, makes high-level decisions, reviews Executive Director performance, and serves as a community advocate for ORCID
- supported by the Executive Director and a full-time professional staff, who are responsible for day-to-day operations and recommending goals and policies

  - ORCID is a non-profit organization funded through organizational membership and fees. To sustain the registry and our mission of addressing the name ambiguity problem in scholarly communications, we rely on membership and funding from the research community.
- **Members receive these benefits:**
  - Access to the Member API, which facilitates registration, deposit, editing, and updating of Record Data and/or read Limited Access Data, with permission from an individual ORCID iD holder ("opt-in")
  - Personalized technical support, integrated application user acceptance testing, a monthly newsletter, and invitations to public events hosted by ORCID
  - Enter nominations for service on the ORCID Board
